E-Tenders are invited from the reputed manufacturer having sufficient experience for erection and setting up of Hi-tech Green House and having set up for buy back of the produce in the Hi-tech Green House in the district of Uttar Dinajpur as per technical specification attached.

1. Construction of Hi-Tech Green House (Area : 1500 Sq.Ft.) For Gerbera/Capsicum

Terms & Condition

1. Two part bid will consists Technical & financial bid separately.
2. **The applicant should quote their rate inclusive of construction, Cost of Materials for Green House, Delivery charges and all other charges including all Taxes if any up to Gram Panchayet level in Uttar Dinajpur of West Bengal.**
3. The bidders must submit the documents online which include PAN, VAT, P-Tax, GST No. and credential.
4. The documents submitted by the bidders should be properly indexed & digitally signed.
5. The bidders must have the credential for the above work in any govt. institution/ local bodies in West Bengal minimum worth Rs. 10 Lakhs during preceding 2 years.
6. The prospective bidder must have to deposit as earnest money of Rs. 20,000/- by pay order / Demand Draft on any nationalized Bank in favour of the West Bengal State Food Processing & Horticulture Development Corporation Ltd (WBSFP&HDCL).
7. The tenderer must have infrastructure to provide post installation services in West Bengal.
8. Bids shall remain valid for a period not less than eighteen(18) months. The quantity of the items is to be considered in anticipation if supply for 18 months.
9. The intending tenderers are required to quote the rate online only. No offline tender will be entertained.
10. **The Tenderer will have to impart training to the farmers regarding production of the respective item in the Green House.**
11. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender and that application will be rejected outright. The West Bengal State Food Processing & Horticulture Development Corporation Ltd. reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
12. Before issuance of the WORK ORDER, the tender inviting authority may verify

the credential(s) and/ or other document(s) of the lowest tenderer, if found necessary. After verification, if it is found that the document(s) submitted by the lowest tenderer is/are either manufactured or false, the work order will not be issued in favour of the said Tenderer.

13. The intending tenderer is required to quote the rate in figures as well as in words.
14. Conditional / incomplete tender will not be entertained.
15. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and he will not be bound to accept either the lowest tender or any of the tenders.
16. Payment will be made on submission of Bill in duplicate along with the completion certificate issued by the concerned District officer or from the competent Authority & also on receipt of payment from the concerned District Authority.
17. Completion of work: the work must be completed within 15 days from the date of issue of work order.
18. The Tenderer must have unit for construction/ manufacturing of structure of required items in West Bengal. Such units will be inspected by the Authority after technical bid, if required.
19. The tenderer should submit the experience certificate duly certified by appropriate authority and give the guarantee for buy back of produce of the above item under the Green House from the respective farmer as per terms and conditions and rate to be fixed by the a District Level Committee involving DHO, Uttar Dinajpur. A declaration in this respect to be given in the technical bid.
