NOTICE INVITING RE-E-TENDER

Re-E-Tenders are invited for supply of **Pomegranate** Plant (detailed specification given below) from NHB Accredited, bonafied and reputed Nurseries to different Block level of different districts in the State of West Bengal.

Name of the Item: **Pomegranate (Tissue Culture/cutting/air-layering/mound layering):**

Variety: Bhagwa, Ganesh

Quantity:- 1500 Pcs. (Approx.)

Desirable technical characteristics:

Terms & Condition

- Two part bid will consists Technical & financial bid separately.
- 2.A) The Prospective bidders must have their own nursery duly accredited by National Horticulture Board (NHB) (in the name of the Bidder) valid up to last date of submission of tender in respect of one or more varieties of the plants to be supplied.

OR

2.B) The Prospective bidders must have their own nursery duly accredited by National Horticulture Board (NHB) in the name of bidder valid up to the last date of submission of tender in respect of any one fruit plant (not necessarily of above items) and the bidder will be Authorized agent of a nursery duly accredited by National Horticulture Board (NHB) in respect of one or more varieties of the plants to be supplied satisfying clause 2A. Letter of Authority will be issued in official letter head of the nursery under clause 2A to the nursery under clause 2B supported with a copy of NHB certificate satisfying clause 2A. All the documents including NHB certificate of nursery under clause 2A and NHB certificate of nursery under clause 2B of Authorized agent along with copy of NHB certificate of originating nursery satisfying clause 2A and the Authorizing letter under clause 2B must be uploaded in technical bid.

3. The applicants must submit their updated Trade license, PAN, P-TAX, and other credentials certificate for supply of Fruit plants to any Govt. Institution/ local bodies amounting to a minimum of Rs. 5 lakh during the period from 1.4.2016 to date of submission of tender. The credentials certificate must show name & value of items supplied and the total value of supply
4. The applicant should upload scanned copies of all documents including Earnest Money Deposit (EMD) and Check List in Annexure –I , in technical folder.
5. The bidders must have a valid accreditation certificate from NHB, Govt. of India in the name of the Bidder in respect of one or more varieties of the plant to be supplied and must submit the relevant documents in support of own nursery, accreditation from NHB and other documents mentioned in Sl. No. 3 in technical bid.
6. The applicant must upload the available stock as per the required specification in his nursery as on last date of submission of tender (The supply must be made from this stock).. He will also mention the variety of the plant to be supplied. The tenderer will upload the stock and variety as per proforma in Annexure II .The Nursery may be inspected by an official team before issuance of supply order. Further the ordered quantity may increase / decrease by 15% to 20% or substantially more/ less of the quantity as mentioned above form time to time.
7. The prospective applicant must have to deposit Rs.20,000/- as earnest money by pay order / Demand Draft on any nationalized Bank in favour of the West Bengal State Food Processing & Horticulture Development Corporation Ltd (WBSFP&HDCL). The scanned copy of EMD must be uploaded in technical folder .
8. The intending bidder may download the tender document from the website <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate. One copy of tender notice duly signed by tenderer in each page is to be uploaded as a consent to accept all terms and conditions as mentioned in tender notice.
9. The Earnest Money Deposit (EMD) along with the copies of all relevant documents as mentioned in Check List as mentioned in annexure I may be sent physically/ through post to the office of the West Bengal State Food Processing & Horticulture Development Corporation Ltd. under sealed cover so as to reach this office before opening date of the technical bid. (Financial quote must not be sent through post / physically)
10. The applicant should quote their rate inclusive of delivery up to Block level in West Bengal including packaging, loading, unloading and all other charges including all taxes if any.
11. The intending tenderers are required to quote the rate online only. Financial Bid will contain rate of items only. No other document will be sent in the financial bid (Folder).
12. The intending tenderer is required to quote the rate in figures as well as in words in financial bid. Rate should be quoted per piece of planting material.
13. The supply must be completed within 15 (fifteen) days from the date of issue of delivery challan. The supplied planting materials will be inspected at the time of receiving of materials. Materials will be delivered at the concerned Block level . The delivery time will be within 10 am to 5 pm. The materials will be checked at the point of delivery. Sufficient time will be provided by the bidder for checking at delivery point. It is estimated that more or less one hour will be required for checking of one thousand plants approximately. Further after delivery of the planting materials a quality report will be collected by concerned DHO/DDH of district within 60 (sixty) days from the date of receiving of the materials and the report will be send to the Corporation immediately. In case of any substandard supply/ mortality, the supplier will have to replace the said quantity within 7 (seven) days, otherwise the value of this quantity will be deducted from their bill. No extra claim will be entertained for such replacement. The concerned DDH/DHO of the District will send the quality report within 60 (sixty) days from the date of the receiving of the materials.

14. Payment will be made on receipt of Quality report from the concerned DDH/DHO of the District & on receipt of payment from the Requisitioning Authority & on submission of Bill in duplicate along with the received challans from the competent Authority, who received the materials.
15. The documents submitted by the bidders should be properly indexed & digitally signed.
16. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. The West Bengal State Food Processing & Horticulture Development Corporation Ltd. reserves the right to cancel the N.I.T. at any time without showing any reason in the interest of the public and no claim in this respect will be entertained.
17. Before issuance of the SUPPLY ORDER, the tender inviting authority may inspect nursery and verify the original credential(s) and/ or other document(s) of the lowest tenderer with original documents, if found necessary. After verification, if it is found that the document(s) submitted by the lowest tenderer is/are either manufactured or false, the work order will not be issued in favour of the said Tenderer and earnest money will be forfeited.
18. Conditional / incomplete tender will not be entertained.
19. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders. In case the accepting Authority observes that the L1 bidder will not be able to supply all the materials in time, then the accepting authority reserves the right to split up offer to L2, L3 and others on L1 price for completion of time bound programme. The Following principle will be observed for distribution of supply amongst different suppliers
 - (a) First priority will be given to L-1 bidder up to the capacity as mentioned in NHB accreditation certificate of L-1 bidder.
 - (b) The quantity of requirement in excess of (a) above will be offered to L-2 bidder up to the capacity in NHB accreditation certificate of L-2 bidder, if L-2 bidder agrees to supply as per L-1 rate.
 - (c) The above procedures will be followed for bidder other than L-1 and L-2, if required.
 - (d) For the purpose of financial bid the State has been divided into 4(four) zones. One supplier/ agency may apply in one or more than one zones. For the purpose of distribution of supply amongst different supplier the requirement of each zone will be considered/ taken up separately and independently for that zone only . In situation when a supplier/ agency bids for more than one zone, then in case he is issued a supply order for one zone following provision of the above as explained, then that amount of supply booked, will be deducted from his capacity, for consideration his NHB certified capacity for supply order for other zone/ zones if required and so on
20. The undersigned reserves the right to call a separate E-Tender by superseding this Tender at any time after expiry of two (2) months or earlier as may be deemed necessary for public interest without assigning any reason thereof.

21. Tenderers are requested to verify the Check List in Annexure I to ensure submission of all documents.

22. The Tender will remain valid upto 31.03.2019.
