NOTICE INVITING E-TENDER FOR SUPPLY OF QUALITY TISSUE CULTURE BANANA
TO DIFFERENT GRAM PANCHAYETS IN THE STATE OF WEST BENGAL

On-line tenders are hereby invited in two bid system from reputed, experienced bonafide T.C. Laboratories Accredited by Department of Bio Technology, Govt. of India within the territory of West Bengal or its regional office in West Bengal and having hardening Unit in West Bengal for supply of **Tissue Culture Banana plants to different Gram Panchayets in the State of West Bengal.**

Name of the Item- Tissue Culture Banana

Variety- Grand Naine

Specification: The Tissue Culture Banana saplings of Grand Naine must be supplied in Poly-Bag which will be sterilized, free from any contaminated media like soil, fully hardened, the standard height of each fully hardened sapling being 10 to 12 inches.

The **Tender processing Fee of Rs. 2000/- (Rupees two thousand) only (nonrefundable)** and the **Earnest Money of Rs 50,000/- (Rupees fifty thousand)only** are required to be delivered in person to the Accounts Section of this Corporation latest by the last date and time of bid submission.

TERMS & CONDITIONS

1. The intending tenderer will be required to participate in e-tendering and all the tenderers should have digital signature for the purpose of participation in e-tender process.
2. The Prospective bidders must have their own Tissue Culture Laboratory duly accredited by Department of Bio Technology, Govt. of India (in the name of the Bidder) valid till 31.03.2020 in respect of the T.C. Banana and have hardening unit facilities for T.C. Banana in the West Bengal.

3. The successful tenderer shall have to supply the tendered item/s, at the specific location of different Gram Panchayets **within 15(fifteen) days from the date of communication of the approval of the Competent Authority.**
4. Participation in the bid shall amount to the bidder's acceptance of the terms & conditions of the e-tender . **The rate should be quoted zone wise as stated in BOQ**
5. Bidder shall submit on or before the last date given in the Notice Inviting e-tender the Technical bid and Financial bid on-line in the prescribed Format **given in the Website.**
6. The Technical bid should consist of the following documents in separate sealed cover-
 - a) The Tender Processing Fee of Rs. 2000/- (Rupees two thousand)only and the Earnest Money of an amount of Rs. 50,000/-(Rupees fifty thousand) only in the form of Pay Order/ Demand Draft from any Nationalized Bank drawn in favour of West Bengal State Food Processing & Horticulture Development Corporation Limited payable at Kolkata issued after the date of issue of this e-tender and to be deposited to the Accounts Section of this Corporation on or before the closing date and time of tender.
 - b) Valid accreditation certificate from Department of Bio Technology (DBT), Govt. of India.
 - c) Self attested copy of PAN Card
 - d) Income Tax Return of the last financial year
 - e) Valid Trade Licence
 - f) Self attested copies of GST Registration
 - g) Up to date Professional Tax Receipt.
 - h) The application must have the credential for supply of Horticultural saplings worth Rs. 10,00,000/- (Rupees ten lakh)only to a Govt. / Semi Govt. Organization/Public Undertaking/Statutory bodies/Local Bodies/ Parastatals in a year within the preceding two years. Such supply must be supported by the payment certificate from the ordering authority.
 - i) Annual financial turnover for supply of quality seedlings/saplings and or for similar nature of work during the last three years, ending on 31st March of the previous financial year, duly audited by a registered Chartered Accountant Firm.
 - j) The tenderer must furnish the supporting documents on-line. Failure to furnish valid documents on-line may lead to rejection of e-tender summarily. The tender is liable to be ignored if complete information is not given therein.

- k) The tender shall consist of two parts 1) Technical Bid and 2) Financial Bid. All information required to define the eligibility of intending tenderer should be furnished in Annexure-1. Financial Bid should consist of all the information sought in prescribed Format only.
 - l) The Technical Bid and Financial bid should be opened on-line only. The Financial Bid of only those bidders shall be opened who will qualify the technical bid evaluation criteria.
 - m) The intending tenderer or his authorized representative may remain present at the time of opening of tender by the constituted Committee
 - n) The tenderer shall quote the rate in the prescribed form (Annexure-II) for any or all of the items as stated above price bid on a single responsibility basis and it should cover all obligations and liabilities of the tenderer. The rate **shall be inclusive of all kind of taxes including the delivery charges loading & unloading for supply of saplings at the specific locations of the Gram Panchayets.**
 - o) The Offered rate **shall remain valid for a period not exceeding one year, no enhancement in the approved rate shall be entertained by the Corporation during the financial year 2019-20.**
 - p) The tenderer is expected to examine all instructions, terms & conditions put in tender before participation in the On-Line tender.
 - q) The **quantity of the tendered item may increase or decrease as per field requirement for which no extra charges can be claimed by the tenderer.**
 - r) Bid Security of the unsuccessful tenderer will be returned to them at the earliest. But it will be forfeited if the bidder intends to withdraw his bid within the period of tender validity. Also the bid security will be forfeited, if the successful tenderer fails to deliver or supply the tendered items within the specified time frame.
7. For e-Filing, the intending bidder may download the tender document from the website <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate. The scanned copies of earnest money and other documents are to be submitted through e-filing.
8. Besides e-Filing, the EMD (Earnest Money Deposit) along with the copies of all documents as mentioning in SL. No. 5 (a to h) should be submitted physically to the office of the West Bengal State Food Processing & Horticulture Development Corporation

Ltd. under sealed cover within the specified time before the technical bid opening. However the Corporation (Tender Inviting Authority) will not be held responsible for late delivery or loss of the DD/ pay order if mailed through post / courier.

9. The bidders must have a valid accreditation certificate from Department of Bio Technology , Govt. of India in the name of the Bidder in respect of one or more varieties of the plant to be supplied and must submit the relevant documents in support of own T.C. Laboratories , accreditation from Department of Bio Technology , Govt. of India. **The T.C. Laboratory will be inspected by an official team before opening of technical bid. The hard copy of stock statement as mentioned above should be reached before opening of technical bid. The NIT submitted of the Tissue Culture Laboratory are liable for rejection if found unsatisfactory as per report of the visiting official team.**
10. The documents submitted by the bidders should be properly indexed & digitally signed.
11. The intending tenderers are required to quote the rate online only. No offline tender will be entertained.
12. During the scrutiny, if it comes to the notice of the Tender inviting authority that the credential(s) and/or any other paper(s) of any bidder is/are incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender and that application will be rejected outright. The West Bengal State Food Processing & Horticulture Development Corporation Ltd. reserves the right to cancel the N.I.T. at any time without showing any reason for the interest of the public and no claim in this respect will be entertained.
13. Before issuance of the WORK ORDER, the tender inviting authority may verify the original documents of the credential(s) and/ or other document(s) of the lowest tenderer, if found necessary. After verification, if it is found that the document(s) submitted by the lowest tenderer is/are either manufactured or fraudulently fabricated , the work order will not be issued in favour of the said Tenderer and earnest money will be forfeited.
14. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders. The accepting authority reserves the right to split up the offer among L2, L3 and others on L1 price for completion of time bound programme.
15. Payment will be claimed by the tenderer on submission of Bill in duplicate along with the receipt challans from the competent Authority and it will be released to the supplier after getting field report and requisite fund from the requiring body.
16. The undersigned reserves the right to call a separate E-Expression by superseding this Expression at any time as may be deemed necessary for public interest without assigning any reason thereof.
