E-Tenders are invited for transportation of Fruit plant saplings from Ayeshpur Farm to the different Blocks/Gram Panchayet of different districts in the State of West Bengal.

Terms & Condition

1. Offer (Technical & financial) bids submitted to be separately.
2. The bidders should quote their rate including transportation, labour charges, loading & unloading and all other charges for delivery up to Block/ Gram Panchayet level in West Bengal. All rates will be inclusive of all applicable taxes. The rates will be quoted per Piece.
3. The applicant should upload scan copies of all documents including EMD in technical cover.
4. The bidders must submit the documents online which will include Trade License for Transport/ Trade License for Nursery (valid on the last date of submission of tender), PAN, P-Tax , and Credential.
5. The documents submitted by the bidders should be properly indexed & digitally signed. The bidders must have the Credential for supply of perishable goods/ plants worth minimum Rs.1(one) lakh during preceding 2 years to Govt. /Local bodies/ others.
6. The prospective bidder must have to deposit Earnest money of Rs.5,000/- by pay order / Demand Draft on any Nationalized Bank drawn in favour of the West Bengal State Food Processing & Horticulture Development Corporation Ltd (WBSFP&HDCL).
7. Bids shall remain valid for a period not less than 1(one) year.
8. The intending tenderers are required to quote the rate online only. No offline tender will be entertained.
9. During the scrutiny, if it comes to the notice to the tender inviting authority that the Credential(s)and/or any other paper(s)of any bidder is/ are incorrect/manufactured/ fabricated, that bidder will not be allowed to participate in the tender and that application will be rejected out rightly. The West Bengal State Food Processing & Horticulture Development Corporation Ltd. reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained
10. Before issuance of the WORK ORDER, the tender inviting authority may verify the Credential(s) and/ or other document(s) of the lowest tenderer, if found

necessary. After verification, if it is found that the document(s) submitted by the lowest tenderer is/are either manufactured or false, the work order will not be issued in favour of the said tenderer.

11. The intending tenderer is required to quote the rate in figures as well as in words.
12. Conditional / incomplete tender will not be entertained.
13. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.
14. The carrying must be completed within schedule date from the date of issue of delivery challan. Materials will be delivered at the concerned Block level/ Gram Panchayet . The delivery time will be within 8am to 4 pm.
15. Payment will be made on submission of Bill in duplicate along with the received challans from the competent Authority, who received the materials.
