NOTICE INVITING RE-E-TENDER

Re-E-Tenders are invited from the reputed seed Producers /Authorized Dealer for supply of 5000 nos. which may increase or decrease by 20% as per field require of composite Kits of vegetable seeds containing of the following items in each kit.

Palak (Open Pollinated Variety) : 150 grams per packet

Amaranthus (Open Pollinated Variety) : 50 grams per packet

Terms & Condition

1. The prospective bidder must have valid Trade License, PAN, GST, P.TAX, valid updated seed license, Authorization letter from the producer (in case of authorized dealer) and credential for supply of vegetable seeds worth minimum Rs.5.00 lakhs in a year during last two preceding years.
2. The bidder should quote their rate considering supply of 5000 nos. which may increase or decrease by 20% as per field require. of composite packets of vegetable seeds containing Palak (Open Pollinated Variety) : 150 g per packet & Amaranthus (Open Pollinated Variety) : 50 gm per packet in each composite packet & including the cost of delivery up to Paschim Bardhman district. The rate in BOQ will be quoted for a kit containing 150 grams Palak & 50 grams Amaranthus.
3. The supply must be completed within 10 days from the date of received of the supply order.
4. The seed materials should be supplied as per specification.
5. The prospective bidder must have to deposit as earnest money of Rs.10,000/- by pay order / Demand Draft on any nationalized Bank in favour of the West Bengal State Food Processing & Horticulture Development Corporation Ltd (WBSFP&HDCL).

6. The intending bidder may download the tender document from the website <https://etender.wb.nic.in> directly with the help of Digital Signature Certificate & necessary cost of tender document which may be remitted through Demand Draft/ pay order issued from any nationalized bank in favour of the West Bengal State Food Processing & Horticulture Development Corporation Ltd. & same may be documented along with earnest money through e-Filing (scanned copy by document scanner to be submitted). (Details of which has been narrated in "Instruction to Bidders").
7. The EMD (Earnest Money Deposit) should be sent physically to the office of the West Bengal State Food Processing & Horticulture Development Corporation Ltd. under sealed cover within 11.09.2019 before 3:00 PM. However WBSFP&HDCL (Tender Inviting Authority) will not be held responsible for late delivery or loss of the DD/ pay order if mailed through post / courier.
8. The documents submitted by the bidders should be properly indexed & digitally signed.
9. Bids shall remain valid for a period not less than 180 days.
10. The officials of the State Seed Testing Laboratory will collect the sample of seeds from the go down of the successful bidder before delivery of the materials in presence of the officials of the Deptt. of FPI&H, Govt. of West Bengal & the Corporation. In case of unsatisfactory germination the Corporation will deduct the bill accordingly & forfeit the earnest money and the supplying company will be black listed by this Corporation.
11. The intending tenderers are required to quote the rate online only. No offline tender will be entertained.
12. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender and that application will be rejected outright. The West Bengal State Food Processing & Horticulture Development Corporation Ltd. reserves the right to cancel the N.I.T. due to unavoidable

circumstances and no claim in this respect will be entertained in the public interest.

13. Before issuance of the WORK ORDER, the tender inviting authority may verify the credential(s) and/ or other document(s) of the lowest tenderer, if found necessary. After verification, if it is found that the document(s) submitted by the lowest tenderer is/are either manufactured or false, the work order will not be issued in favour of the said Tenderer.
14. All tenderers are requested to be present during opening of tenders positively. In no case his / their absence will stand against holding the same.
15. The intending tenderer is required to quote the rate in figures as well as in words.
16. Conditional / incomplete tender will not be entertained.
17. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and he will not be bound to accept either the lowest tender or any of the tenders.
18. 20% of the Bill value will be made on submission of Bill in duplicate along with the receipted challans from the concern District Authority & balance 80% payment will be made on receipt of satisfactory field report from the concern District Horticulture officer after 90 days from the date of supply.
