NOTICE INVITING E- TENDER

E-tender are invited from the reputed hybrid seed producers having credential for supply of different hybrid seeds suitable for soil & climatic condition of West Bengal for supply of the following hybrid seeds as per the following terms & condition:

Terms & Condition

1. Eligibility criteria for participation in the Tender

- i. The applicant company must have the R&D Certificate recognized by the Department of Bio-Technology Govt. of India with upto date validity. The documents in this respect of the R&D is to be submit in Technical Bid.
 - ii. The applicants must submit their Trade license, PAN, P-TAX,GST, audited balance sheet of last two years, Banker's Solvency certificate worth Rs. 1 Lakh,
 - iii. Credential for supply of hybrid seeds in Govt. Deptt./ PSU in any State in India worth not less than five lakhs in any financial year for preceding last two years must be supported by payment certificate or work completion certificate from the order issuing authority.
 - iv. Performance report in respect of the tender items from ICAR/IARI/SAU
2. The applicant should submit the above documents along with the Technical data of their produced hybrid seeds in a separate envelope mentioning "Technical Bid"

Also the applicant must submit the Brand name in the following Proforma for each item for which rate has been quoted in the financial bid. Rate without company name will not be accepted.

3. The applicant should quote their rate with standard small packaging size considering delivery up to Block level in West Bengal including packaging, loading, unloading etc along with their brand in a separate envelope mentioning financial bid.
4. The financial bid will be opened only for the applicants who will qualify in the Technical Bid.

5. *Earnest Money*

I. **Online Deposition of Earnest Money and Tender Fee**

The Tenderers desirous of taking part in the tender have to deposit Earnest Money @ Rs. 50,000/- and Tender Fees @ Rs. 2,000/- through ICICI Bank Payment Gateway.

For deposition of EMD and Tender Fee (at the prescribed rate), the Bidders can refer to the user manual available in “ Bidders Manual Kit (Point 10)” regarding payment methods . Payment should not be made in Corporation Account directly. It should be deposited through available options on the tendering portal only.

II. **Refund of Earnest Money deposit**

The Earnest Money of all unsuccessful tenderers will be refunded by the WBSFPDCL within 30 days from the date of finalization of tender on receipt of application from the tenderers. In case of successful tenderer, the Earnest Money deposit will be released after 90 days counted from the date of completion of supply. No interest on Earnest Money will be paid by the Corporation.

III. **Forfeiture of Earnest Money deposit**

Earnest Money deposit is liable for forfeiture in the event of:

- a) Withdrawal of offers, while offers are under consideration during the validity period.
- b) Non acceptance of supply order.
- c) Any unilateral revision made by the tenderer during the valid period of the offer.
- d) Failure to execute supply of the entire order or part thereof.

6. The documents submitted by the bidders should be properly indexed & digitally signed.
7. Bids shall remain valid for a period of one year.
8. The intending tenderers are required to quote the rate online only. No offline tender will be entertained.
9. After placement of order to the successful lowest bidder the company will collect the sample of seeds at the time of delivery (four packet of each variety) and will send it to the State Seed Testing Laboratory for necessary testing. In case of unsatisfactory germination the Corporation may cancel the order & forfeit the earnest money and the supplying company may be black listed by this Corporation. The Corporation will not be liable to pay the cost of seed fully or partially for the seed already supplied from the said batch / lot which are unsuccessful in the test report.

10. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender and that application will be rejected outright. The West Bengal State Food Processing & Horticulture Development Corporation Ltd. reserves the right to cancel the N.I.T. at any time without showing any reason for the interest of the public and no claim in this respect will be entertained.
11. Before issuance of the WORK ORDER, the tender inviting authority may verify the credential(s) and/ or other document(s) of the lowest tenderer with original documents, if found necessary. After verification, if it is found that the document(s) submitted by the lowest tenderer is/are either manufactured or false, the work order will not be issued in favour of the said Tenderer and earnest money will be forfeited.
12. The intending tenderer is required to quote the rate in figures as well as in words in financial bid.
13. Conditional / incomplete tender will not be entertained.
14. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders. The accepting authority reserves the right to split up offer L2, L3 and others on L1 price for completion of time bound programme.
15. Payment will be made on submission of Bill in duplicate along with the receipted challans from the competent Authority & also on receipt of payment from the concerned District Authority.
