NOTICE INVITING Re-E-TENDER

1. Invitation

Re-e-tenders are hereby invited from the reputed, experienced, NHB accredited Nurseries of West Bengal having sufficient financial capabilities for planting/ raising of about 1,50,000 nos. of Mango plants (Amrapali) at Mohtinagar farm, Dist.- Jalpaiguri.

Estimated cost for planting/ raising of about 1,50,000 nos of Mango (Amrapali) sapling at Mohitnagar Farm, Jalpaiguri, W.B. is as below-

- The Earnest Money Deposit (EMD) may be submitted physically/sent through post to the office of the West Bengal State Food Processing & Horticulture Development Corporation Ltd. under sealed cover so as to reach this office before opening date of the quotation.

2. Eligibility criteria for participation in the Tender

- i. Experienced, bonafide Bidders having NHB accredited Nurseries (in the name of the Bidder) with approved capacity of the raising the horticultural plants (including Mango) of about 2 Lakh.
- ii. Copies of PAN Card, P.Tax Deposit Challan for the year 2018-19/ 2019-20, Trade License (valid on the last date of submission of Tender) and Xerox copy of the Bank Passbook of the outstanding amount of Rs. 2 Lakh as on 31.10.2019 should be submitted by the Tenderers.

3. Submission of Tender

Tenders are to be submitted through online to the website as stated in two folders, one is Technical bid and the other is Financial bid, before the scheduled date and time using the Digital Signature Certificate.

The technical proposal shall contain the scanned copies of the following-

- Application in Annexure-II duly signed by the applicant.
- **Copies of-**
 - i) PAN Card
 - ii) P. Tax Deposit Challan for the financial year 2018-19/2019-20
 - iii) Trade License (valid on the last date of submission of the Tender)
 - iv) EMD
- Xerox copy of the Bank Passbook of the outstanding amount of Rs. 2 Lakh as on 31.10.2019
- The Financial proposal should contain-
- Bill of Quantity (BOQ):-The supplier is to quote the rate online in the space marked for quoting against the indicative price assessed by the Corporation. The rate is to be quoted in figure as well as in words.
- **The participant will be rejected in case it is uploaded in the Technical Bid.**

Failure in submission of any of the above documents may render the tenderer liable to be rejected.

GENERAL TERMS AND CONDITIONS

I. Refund of Earnest Money deposit

The Earnest Money of all unsuccessful tenderers will be refunded by the WBSFPHDCL within 30 days from the date of finalization of tender on receipt of application from the tenderers. In case of successful tenderer, the Earnest Money deposit will be released after 90 days counted from the date of completion of work. No interest on Earnest Money will be paid by the Corporation.

II. Forfeiture of Earnest Money deposit

1. Earnest Money deposit is liable for forfeiture in the event of:

- a) Withdrawal of offers, while offers are under consideration during the validity period.
- b) Non acceptance of work order.
- c) Any unilateral revision made by the tenderer during the valid period of the offer.
- d) Failure to execute the work of the entire order or part thereof.

2. Responsive Tenderer

Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.

4. Quoting the rates

- a. The intending tenderers are required to quote the rate against the indicative price of item.
- b. The price should be firm, final and irrevocable and not subject to any change whatsoever even due to increase in cost of raising of planting materials, other components, Labour cost etc. and any changes or imposition of statutory levies till the completion of supply as per order.

5. Rate Validity

The rate shall remain effective ordinarily up to 31.3.2020 which may be extended further with mutual consent between the bidder and WBSFPDCL unless terminated prematurely at its discretion and satisfaction.

6. Issue of supply order.

Before issuance of supply order, the Tender Inviting Authority may physically verify the credentials and other documents of the lowest tenderer if found necessary. After verification, if it is found that the documents submitted by the lowest tenderer are either manufactured or false, in that case supply order will not be issued in favour of the said tenderer under any circumstances and the Earnest Money deposited to this effect will be forfeited.

7. Completion period of supply

The tenderer shall have to raising the plants upto the desired height (2 ft.) with a period of 4(for) months from the date of issuing of work order.

8. Changes in Specifications

The Corporation may require any changes in specifications; the tenderer shall use his best endeavour to comply with the Corporation's requirement in respect of specifications.

9. Adherence to the prescribed Specifications

No deviation from the specifications prescribed by the Corporation will be accepted by the Authority.

10. Right to accept any bid and/ or to reject any or all bids

The Corporation reserves the right to accept or reject any or all bids and to annul the tendering process and all bids prior to issue work order, without thereby, incurring any liability to the affected tenderer or tenderers or any liability to inform the tenderer of the ground for such action.

11. Delay in execution of work-

It is emphasized by the Corporation and understood by the tenderer that the period of complete stipulated in the order is the essence of the work. It is admitted by the supplier that any delay may obviate the necessity of work and thereby affect the interest of the Corporation. If the reason of delay is beyond the control of the Tenderer, then it should be communicated to the Corporation in writing for its necessary intervention.

12. Disputes

Any dispute arising out of noncompliance of any Terms and Conditions of the Tender, it shall be referred to sole Arbitrator, who shall be appointed by the Corporation in accordance and subject to the provision of the Arbitration and Conciliation Act, 1996. The place of Arbitration will be Kolkata and the language shall be English. The Award of the Arbitrator shall be binding on both the parties. All disputes and Court cases are subject to the Jurisdiction of the Calcutta High Court only.

13. Negotiations

It is clarified that normally no rate negotiation will be done and therefore the Tenderer should quote their lowest prices only, however, the Corporation may negotiate the rates in exigencies, if required to do so.

14. Payment of Bill

Payment will be claimed by the Tenderer on submission of the Bill in duplicate along with the work completion certificate duly signed by the Horticulturist.
