4. **The Contractors / Agencies may quote their rates against the mentioned work in Annexure - I and drop the same in a sealed envelope during office hours in the tender box kept at the General Section of WBSFPDCL office at the above mentioned address starting from 19.07.2023 at 12:00 Noon (Date of Publication of NIQ) upto 26.07.2023 by 3:00 PM. Received quotations will be opened on same day at 4:00 PM.**
5. The Work Order is normally be issued to the L-1 Bidder for execution of the work. However, the Quotation Inviting Authority reserves the right to accepting a bid other than the lowest on a specific ground to be recorded in writing.
6. The successful bidder who will get work order shall undertake the commencement of work on 01.08.2023 and do the Maintenance Work as per Specification mentioned above till 31.07.2024.

7. **Apart from mandatory service of the machines, if sudden breakdown of the Machines occurs, the agency who will do the maintenance work, have to inspect the machines within 24 hours of informing them and has to do the repair work immediately. The entire cost of repair work will be borne by the agency including cost of materials / parts.**

The Corporation will not take any responsibility for payment until it has received payment from the concerned Govt. Departments/ Authority. No interest can be claimed by the Agency for any delay of receiving payment from Indenting Authority through Bank Transfer, to the bidder's acknowledged Bank Account, after deducting penalties, if any, arising due to sub-standard/ delay work.
